- (V) Counselling process will be stopped immediately after filling up of all seats
- (VI) The selected candidate after counselling will be informed through e-mail/sms in his/her registered mobile number for making online payment of Rs. 3,000/- (Rs. Three Thousand) (Rs. 2000/- as course fee and Rs. 1000/- as caution money) through the web portal www.scertonline.tripura.gov.in by debit card/credit card/online banking system etc.
