#### **GENERAL**

State Council of Educational Research & Training (SCERT) invites sealed tenders from well established, experienced, reputed and professionally run printing/publishing houses in Tripura possessing requisite technical capabilities other eligibility criteria for production of a series of digital videos on L1 basis for the State Council of Educational Research & Training (SCERT), Agartala for production of 180 nos. full HD quality digital video (with duration of 10-20 minutes each).

The interested bidders will have to apply in the prescribed format for both technical and financial bids. The interested bidders have to pay an earnest money deposit (EMD) of Rs.4,000/-by Cheque / Demand Draft drawn in favour of H.O. & D.D.O SCERT, Agartala payable at Agartala. The cheque/demand draft of **Rs. 4,000/-** may be kept in the envelope for technical bid. The bids without earnest money will be summarily rejected.

The EMD shall be released within one month of successful award of work. No interest will be payable on EMD.

The time schedule for submission and opening of bid is as under:-

The bid document, complete in all respects and sealed properly shall be submitted at State Council of Educational Research & Training (SCERT), Agartala (Abhoynagar, Near District Education Office, Agartala -799005) w.e.f. 12 noon of 07.11.2020 till 2 p.m. of 13.11.2020.

The financial bid of the bidders who do not comply to requisite specification & fulfill other conditions as mentioned in the technical bid shall not be opened. One authorized representative of each of the bidder may be present at the time of opening of the bid.

### TERMS AND CONDITIONS

#### **Eligibility Criteria:**

- 1) The bidder should have experience of production of 20 nos. digital videos, recording and editing of high quality (Full HD 1080  $\times$  1920 resolution ) videos in last one year .
- 2) The agency should have a valid Trade License.
- 3) Copy of GST registration certificate to be submitted along with Technical bid if applicable .

- 4) Copy of the PAN.
- 5)An Earnest Money deposit of Rs.4000/- by Cheque / Demand Draft drawn in favour of H.O. & D.D.O SCERT, Agartala payable at Agartala. The demand draft of Rs.4,000/-may be kept in the envelope for technical bid. The bids without Earnest Money will be summarily rejected.
- 6)The Agency shall provide undertaking for maintaining Privacy, for avoiding Conflict of Interest, Statement for Non-Vested Interest & for maintain high levels of Standards & professionalism in providing latest & updated information/technology to SCERT, Tripura particularly in respect of any change taking place subsequent to the tender submission.
- 7) The Agency/ Firm shall provide certificate that the firm/ Agency is not Black-Listed by any Government Department or Ministry and no criminal case / complaint is pending against them anywhere in Tripura.
- 8) The Successful L1 bidder/s shall have to enter into separate agreement with SCERT, AGARTALA (on non-judicial stamp of Rs.20).
- 9) The agreement will be valid for one year and can be extended further based on the performance.

#### INTELLECTUAL PROPERTY RIGHT:

SCERT, AGARTALA will hold the Copyright, Trade Rights and Intellectual Property rights and it may be used for further research and teaching purpose, publicity, marketing, branding, product positioning of the SCERT, AGARTALA as whole on other platforms.

#### **Indemnity Clause**

The Agency shall indemnify the SCERT, AGARTALA for any injury or loss or damage caused to SCERT, AGARTALA on account of any infringement of copyright of another person or persons or on account of any defamatory or otherwise injurious matter contained in the produced video.

SCERT, AGARTALA reserves the right to cancel the tender or reject any bid in part or full without assigning any reason. SCERT, Agartala also reserves the right to distribute the work to the qualified other bidder/s at accepted L1 rate.

#### Scope of Work:

The Assignment or production work shall entail recording and editing. It will not be limited to the digital videos and also including voice over, background music, speeches, royalty free footage and many others which are required to complete the assignment on agreed time schedule basis.

The empanelled agency must have in-house production facility. The entire data will also be sorted/ archived and the firm has the responsibility to provide and maintain the backup, storage and recovery mechanism. The specification and other parameters of the book are as under:-
