The Bids shall be submitted in three separate sealed envelopes asunder: -

(a) Envelop A- should contain the Bank drafts (s) for the Earnest Money Deposit (EMD), Tender Fee along with the details in (Annexure-I), Annexure-II and Tender Document duly signed by the bidder on each page and all necessary documents to be submitted along with the Technical Bid.

The Bidder should have a required license issued by competent authority (Attested copy should be attached with Technical Bid).

Copies of Income Tax Return, Audited Balance Sheet, GST Registration certificate, Valid Registration Certificates issued by competent authorities under GST/CST acts, copy of shall be enclosed in the technical bid.

The Bidder should not have been black listed by the Departments of State Govt. / Govt. of India Organizations.

All the information submitted by the Bidder shall be presumed to be true to be best of the knowledge of the bidder.

## 7. TERMS AND CONDITION OFBID:

The bids must be accompanied with a Demand Draft issued by any Nationalized Bank for Rs.5,000/- (Rupees five Thousands only) in favour of Director, SCERT, Tripura payable at Agartala towards EMD.

The Technical Bids shall be opened at SCERT, Tripura by a duly constituted Committee in the presence of such bidders or their authorized representatives who may desire to be present at the time of opening of bids.

It is the responsibility of Bidders to read all terms & conditions of this document carefully before filling the bid. Incomplete bid documents or bids not responsive enough to the terms & conditions are liable to be rejected. The bidder should sign undertaking along with the bid document that he has read the complete tender document and will abide by its terms & conditions.

The bid shall contain no erasures or overwriting except as necessary to correct errors made by the bidder, in which case such corrections shall be authenticated by the person or persons signing the bid.
